

1. Introduction

This General Fees Policy outlines the fees and charges applicable to all products and services provided by Olympus Broker. By opening and operating an account with us, you agree to all fees detailed herein, which may be updated from time to time.

2. Trading Fees

A. Binary Options & Digital Contracts

- **Spread:** Included in the quoted price.
- **Commission:** No direct commission.
- **Payout Structure:** Up to 95% per winning trade, depending on the asset and market conditions.
- **Loss:** 100% of the trade amount for unsuccessful trades.

B. CFDs (Contract for Difference)

- **Spread:** Variable depending on asset class and market volatility.
 - **Commission:** May apply to specific instruments (e.g., cryptocurrencies or stocks).
 - **Swap/Overnight Fee:** Applies to CFD positions held overnight (except for swap-free accounts). Fee is calculated based on the notional value of the position and varies by instrument.

3. Deposits and Withdrawals

A. Deposit Fees

- **Olympus Broker charges no internal deposit fees.**
- External fees from banks, e-wallets, or payment processors may apply and are the responsibility of the client.

B. Withdrawal Fees

- **Processing Fee:** Up to 0% per withdrawal, depending on the payment method and withdrawal amount.
 - **Minimum Withdrawal Amount:** \$10 (or currency equivalent).
 - **Boleto Exception:** Withdrawals following Boleto deposits require a 72-hour waiting period.

4. Inactivity Fee

An inactivity fee of **\$10 per month** is charged if:

- The account remains inactive (no trades, deposits, or withdrawals) for **90 consecutive days**.

The fee continues to be charged monthly until the balance reaches zero or account activity resumes.

5. Currency Conversion Fees

For transactions in a currency other than your account base currency:

- A conversion fee of **up to 2.5%** may apply.
 - Rates are based on market exchange rates with an added margin to account for risk and liquidity.

6. Other Applicable Charges

- **Chargeback Handling Fee:** \$50 per incident.
- **Expedited Withdrawal Processing:** \$25 per expedited transaction (processed within 24 business hours).

- **Verification Failure Reprocessing:** Up to \$15 if ID/KYC documents must be resubmitted due to inconsistency or client-side error.
